RESOLUTION NO. 01-04

A RESOLUTION OF BIG SKY COUNTY WATER & SEWER DISTRICT NO. 363, MONTANA, TO EXCLUDE CERTAIN LAND FROM THE DISTRICT

WHEREAS, the Big Sky County Water & Sewer District No. 363, Montana (the "District") is a county water or sewer district, validly organized pursuant to Title 7, Chapter 13, Parts 21 and 22, M.C.A.; and

WHEREAS, the District was incorporated on August 5, 1993 and is located within the boundaries of Gallatin County and Madison County, political subdivisions of the State of Montana; and

WHEREAS, the Board of Directors (the "Board") of the District adopted Resolution No. 1993-30, on August 3, 1993, which described and set forth all land within the District; and

WHEREAS, pursuant to Section 7-13-2348, M.C.A., the Board is authorized to initiate proceedings for the exclusion from the District of any land or lands which it may not be for the best interest of the District to be included or which may not be benefitted in any manner by its continued inclusion in the District; and

WHEREAS, the Board has identified land which can not and will not under the District's long term facility plans be benefitted from either the District's water system or sewer system and which it believes should be excluded from the District.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors (the "Board") of the District as follows:

Section 1. <u>Land to be Excluded</u>. The Board hereby determines that the land described, shown and depicted on Exhibit A, attached hereto and incorporated herein, is the land the Board intends to exclude from the District.

Section 2. <u>Public Hearing</u>. A public hearing shall be held on November 20, 2001, commencing at 3:30 p.m. at the District office, Big Sky, Montana, for the purpose of hearing why such lands should not be excluded.

Section 3. <u>Notice</u>. The District Secretary is hereby authorized and directed to publish or cause to be published a copy of a notice of the passage of this resolution in the *Lone Mountain Lookout and the Madisonian*, newspapers of general circulation in the District, on November 1, November 8 and November 15, 2001, in the form and manner prescribed by law, and to mail or cause to be mailed a copy of said notice to all persons who own property in the District and who

by virtue of the proposed action would be excluded from the District. All interested persons should appear before the Board and show cause why such lands should not be excluded
