RESOLUTION NO. 02-04

A RESOLUTION OF BIG SKY COUNTY WATER & SEWER DISTRICT NO. 363, MONTANA, AUTHORIZING THE ENTERING INTO, EXECUTION AND DELIVERY OF A COMMITMENT AGREEMENT WITH THE DEPARTMENT OF NATURAL RESOURCES AND CONSERVATION REGARDING THE SALE AND DELIVERY OF THE DISTRICT'S \$13,500,000 SEWER SYSTEM REVENUE BOND (DNRC WATER POLLUTION CONTROL STATE REVOLVING FUND PROGRAM), SERIES 2002

WHEREAS, the electors of the Big Sky County Water & Sewer District No. 363, Montana (the "District") at an election held on May 7,2002, authorized this Board of Directors (the "Board") to issue and sell bonds of the District in the aggregate principal amount of \$13,500,000 for the purpose of paying for the costs of designing and constructing improvements to the sewer system (the "System"); and

WHEREAS, the Department of Natural Resources and Conservation (the "DNRC") has provided to the District a form of Commitment Agreement between the District and the DNRC, a copy of which is attached as Exhibit A (the "Commitment Agreement") and pursuant to which the DNRC will loan the District \$13,500,000 to pay the costs of financing certain improvements to the System as described on Exhibit A to the Commitment Agreement and the District will evidence its obligation for the Loan by the issuance of its Sewer System Revenue Bond in the same amount (the "Bond"); and

WHEREAS, the District has reviewed the Commitment Agreement; and

WHEREAS, it is the judgment and determination of the Board that it is in the best interest of the District to approve and enter into a Commitment Agreement.

NOW, THEREFORE, BE IT RESOLVED By the Board of the District as follows:

1. <u>Approval of Commitment Agreement.</u> The Board of the District hereby approves the terms and provisions of the Commitment Agreement and hereby authorizes the President and Secretary of the District to execute and deliver the Commitment Agreement to the DNRC.

2. <u>Authority to Proceed</u>. The President, Secretary and the General Manager of the District are hereby authorized to take all actions necessary and desirable to proceed with the issuance of the Bonds to the DNRC in accordance with the provisions of the Commitment Agreement and other applicable provisions of Montana law.
