WHEREAS, the board of directors find that it is necessary to elect 2 board of directors at the election in 2009.

# NOW THEREFORE, BE IT RESOLVED:

- 1. A board of director election for the above-named water/sewer district to elect 2board of director(s) shall be held on November3, 2009; and
- 2. Nominating petitions for candidates for board of director may be filed with the Gallatin County Election Department no later than August 20, 2009. If the number of candidates is equal to or less than the number of positions to be elected, the board of directors shall declare elected by acclamation each candidate who filed a nominating petition for a position. If no candidate filed a nominating petition for the position, the board of directors shall make an appointment to fill the position and the term is the same as if the director were elected.
