This is to update the status of the RID 305 lawsuit with Simkins-Taylor Trust.

Simkins, one of the plaintiffs, requested and was granted a continuance of the hearing from January 28, 1987 to March 4 & 5, 1987. This poses no problem and we still have ample hookups for any new development at the present time.

Contrary to the rumors that have been spread recently around the area, the approval of our plan is still intact and will remain intact. The Supreme Court of the State of Montana has not invalidated any of the documents on file in the District Court or elsewhere. The State Department of Health and Environmental Sciences has not withdrawn the approval of our plan in any manner.

If there are any questions regarding our status, the Directors of the RID 305 would certainly appreciate the questions directed to us instead of listening to the "rumor mill" which you know are generally untrue.


It was moved by Ray Tout after discussion that we purchase two fans for the treatment building, change the thermostate on the heater and install a phone with one extention for RID - 305.




